Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

MEASURING and HEIGHT CARD INFORMATION

Exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Dogs without a valid Jump Height Card/Form may still compete, but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present, **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores. **THE JUDGE IS NOT A VMO, IF YOUR DOG DOES NOT HAVE A TEMPORARY HEIGHT CARD, PLEASE GET WITH THE JUDGE WELL BEFORE TIME FOR YOUR CLASS**

When filling out the entry form, there is a section at the top of the form for exhibitors to designate if your dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*.

DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

MOVE-UPS

Move-ups for the first day the dog is trialing must be received by 6 p.m. Monday, October 19, 2026 in writing. **Email is preferred, just reply to your confirmation.** Day to Day move-ups is also offered. There will be forms available at the trial and the Trial Secretary must receive the request on paper immediately after the last class of the day.

COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

RIBBONS, AWARDS, AND PRIZES

Rosettes will be awarded in each jump height division in each class as follows:

<i>First Place</i>	<i>Blue</i>
<i>Second Place</i>	<i>Red</i>
<i>Third Place</i>	<i>Yellow</i>
<i>Fourth Place</i>	<i>White</i>
<i>Qualifying Score</i>	<i>Flat Dark Green</i>

Dogs must qualify to receive a placement, Rosette. The NCBCC will also award MACH and PACH Rosettes and bars, and AGCH and New Title Rosettes. All awards must be claimed at the trials; none will be mailed.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The **NCBCC** and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dog **NCBCC** reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the **NCBCC** or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Bitches in season are not permitted to compete in Agility Trials. As such, the club will refund all but \$5 per run per day of the entry fee paid for bitches unable to compete for this reason upon presentation of a veterinarian certificate. This certificate must be presented to the Trial Secretary prior to the start of judging on the first day of the trial or cluster of trials. The club will refund all but \$7 per run per day for dogs unable to compete because of injury upon presentation of a veterinarian certificate. Certificates must be given to the Trial Secretary at least 1/2 hour before the start of the trials.

RINGSIDE

Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. See Height Card Information in this premium for dogs without a height card. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

From the North or South: Interstate 81, Exit 310 (Kernstown). Take Route 37 and then Route 11 North to Right on Commonwealth Court. The Site is on the left at the end of the road.

Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day. Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Entering For Exhibition Only (FEO)

As of July 2 2024, For Exhibition Only may be offered at the option of the host club. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. **FEO is offered in all classes. Participation in FEO is non-qualifying, and must be announced to the judge upon entering the ring**

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring
 - Toys must be non-audible
 - Toys may not leave the handler's hand
 - Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

Fix and Go On (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not up to their Std. this allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine PartnersSM** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner? _____
